You will work through the following units as part of Working with Children.

Unit 1: Practical Component

Planning and preparing resources for playgroup and participation in playgroup sessions.

Unit 2: Safety and Young Children

You will learn how to identify and address safety and design needs in the childcare environment, ensuring activities, toys, resources and environments are safe.

Unit 3: Child Growth and Development

Explore how children's physical, cognitive, social, and emotional development impacts their needs and abilities. These changes influence how children engage in the childcare environment.

Unit 4: Guiding Children's Behaviour

Explore strategies and theories on guiding children's behaviour, including influencing factors and the rights and responsibilities of the child, parent, carer and state.

Unit 5: Play and learning

Learners will investigate different types of play, their theories, developmental stages, and benefits.

Unit 6: Food and Nutrition

Investigate principles of good nutrition and health, when feeding toddlers and young children.

Unit 7: Children and Technology

Explores the use of technology in play and learning for young children, examining its positive and negative impacts, and observing its application in childcare and home settings.

How you'll be assessed:

Common types of internal assessments are:

- Practical participation and engagement in playgroup sessions as evidenced in your journal
- Written assessment tasks and assignments
- Folio of activities including planning and evaluations in your playgroup journal

For students to be successful in this subject you will need to:

- Obtain a Working with Vulnerable Children Registration card, prior to playgroup sessions starting.
- Participate in the playgroup sessions (including planning and preparation of resources).
- Complete set theory work within the playgroup journal.
- Complete theory-based assignments.



COMPLETION OF WORK

- Verify your identity Proof of Identity Fact Sheet
- Have your photo taken
- Pay the \$22.44 volunteer application fee

A parent/guardian must attend with you. They must:

- Meet identity requirements
- Provide proof of relationship (e.g. birth certificate)

Processing will not begin until all steps are complete.

Once you receive your card:

- Bring it to school for your teacher to scan. Launceston College is required to keep a record of your
 Working with Children Registration Card.
- Keep it stored securely

ASSESSMENT

Criterion-based assessment helps students see how well they're meeting course outcomes at the end of their study. While there is continuous feedback to guide learning, final assessments focus on showing what students have achieved by the end. Ratings are given as 'A', 'B', or 'C', based on course standards. A 't' indicates partial achievement below a 'C', and a 'z' means no evidence provided.

Schools follow TASC's quality assurance to keep standards consistent. More details are on the <u>TASC website</u>. Final awards are based on both internal and TASC-supervised external assessments.

Criteria

The assessment for Working with Children, Level 2, will be based on the degree to which the learner can:

- 1. interact appropriately with children and engage children in learning activities
- 2. locate, organise, and record information about children from practical and theoretical sources
- 3. identify the nature of child growth and development
- 4. work effectively and cooperatively in childcare environments
- 5. use communication skills with children and others
- 6. design, prepare, implement, and assess environments, resources, and activities for children
- 7. identify the provisions of childcare environments.

Award Requirements

The final award will be determined by the Office of Tasmanian Assessment, Standards and Certification from 7 ratings.

The minimum requirements for an award in Working with Children Level 2 are as follows:

EXCEPTIONAL ACHIEVEMENT (EA)

5 'A' ratings, 2 'B' ratings

HIGH ACHIEVEMENT (HA)

3 'A' ratings, 3 'B' ratings, 1 'C' rating

COMMENDABLE ACHIEVEMENT (CA)

4 'B' ratings, 2 'C' ratings

SATISFACTORY ACHIEVEMENT (SA)

6 'C' ratings

PRELIMINARY ACHIEVEMENT (PA)

4 'C' ratings

A learner who otherwise achieves the rating for a SA (Satisfactory Achievement) award but who fails to show any evidence of achievement in one or more criteria ('z' notation) will be issued with a PA (Preliminary Achievement) award.
